**FIRST AMENDMENT TO
PATENT AND TRADEMARK SECURITY AGREEMENT**

THIS FIRST AMENDMENT TO PATENT AND TRADEMARK SECURITY AGREEMENT (this “Amendment”), dated as of October 4, 2022 (the “Effective Date”), is by and among TASK FORCE TIPS LLC, a Delaware limited liability company (the “Company”; and together with any other Person that becomes a Grantor as provided herein, the “Grantors” and each, a “Grantor”), in favor of CIBC Bank USA, in its capacity as administrative agent for the benefit of the financial institutions (the “Lenders”) that are parties to the Credit Agreement referenced below from time to time (in such capacity, the “Administrative Agent”).

RECITALS

A. Grantor and Administrative Agent have entered into that certain Patent and Trademark Security Agreement dated as of March 6, 2020 (as the same may from time to time be amended, modified, supplemented or restated, the “Patent and Trademark Security Agreement”), pursuant to which Grantor has granted Administrative Agent, for the benefit of the Lenders, a continuing security interest in and to all of the “Trademark Collateral” and “Patent Collateral”, as defined in the Patent and Trademark Security Agreement.

B. Grantor, Madison Safety & Flow LLC, a Delaware limited liability company, the guarantors party thereto, the financial institutions that are or may from time to time become parties thereto and Administrative Agent are entering into that certain Amended and Restated Credit Agreement as of the Effective Date.

C. The Company has obtained an additional ownership interest in certain Trademark Collateral and Patent Collateral and the parties wish to amend Schedule 1 to include such additional Trademark Collateral and Schedule 2 to include such additional Patent Collateral.

AGREEMENT

NOW, THEREFORE, the parties agree as follows:


1. Definitions. Capitalized terms used but not defined in this Amendment shall have the meanings given to them in the Patent and Trademark Security Agreement.
2. Schedule 1. Schedule 1 attached hereto amends and replaces that certain Schedule 1 which was attached to the Patent and Trademark Security Agreement.
3. Schedule 2. Schedule 2 attached hereto amends and replaces that certain Schedule 2 which was attached to the Patent and Trademark Security Agreement.
4. Affirmation. Except the amendments to Schedule 1 and Schedule 2, the Patent and Trademark Security Agreement and all covenants, terms, conditions, and agreements therein, shall remain in full force and effect, and are hereby ratified and confirmed in all respects by Grantor.

5. Counterparts. This Amendment may be executed in any number of counterparts and all of such counterparts taken together shall be deemed to constitute one and the same instrument.
