**TERMINATION AND RELEASE OF INTELLECTUAL
PROPERTY SECURITY AGREEMENT**

This **TERMINATION AND RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENT** (this “*Termination and Release*”) is granted as of November 9, 2022 by **SILICON VALLEY BANK**, as administrative agent (“**Administrative Agent**”), in favor of **3PL INTERMEDIATE HOLDINGS, LLC**, a Delaware limited liability company, **3PL CENTRAL LLC**, a Delaware limited liability company, **TS TRACKER SYSTEMS, INC.**, a California Corporation, and **SKUBANA INC.**, a Delaware Corporation (collectively, the “**Grantor**”).

WHEREAS, the Grantor executed and delivered an Intellectual Property Security Agreement, dated as of April 5, 2021 (the “**Agreement**”), granting to Administrative Agent a security interest in all of its right, title and interest, whether presently existing or hereafter acquired, in, to and under its Intellectual Property (as defined in the Agreement), including the Trademarks (as defined in the Agreement), notice of which was recorded with the United States Patent and Trademark Office (“**USPTO**”) on April 5, 2021 at Reel 7244, Frame 0476, and the Copyrights (as defined in the Agreement), notice of which was recorded with the United States Copyright Office (“**USCO**”) on April 5, 2021, at Volume 15001, Document No. 590;

WHEREAS, Grantor has requested that Administrative Agent hereby terminate, release and discharge fully its security interests in and liens on all right, title and interest of Grantor in, to and under all of its Intellectual Property, including the Trademarks and Copyrights as herein provided; and

WHEREAS, Grantor has requested that Administrative Agent provide a document suitable for recording with the USPTO and USCO to evidence the release of Administrative Agent’s security interests in and liens on its Intellectual Property, including the Trademarks and Copyrights as herein provided.


NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Administrative Agent hereby:

1. *terminates the Agreement and releases, terminates and discharges fully all liens and security interests thereunder in Grantor’s right, title and interest in, to and under its Intellectual Property, including, without limitation, those trademarks, trademark applications, copyrights and copyright applications identified in Schedule I and Schedule II respectively hereto; and*
2. *authorizes and requests that this Termination and Release be recorded with the USPTO and USCO.*
