RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY

THIS RELEASE OF SECURITY INTERESTS IN INTELLECTUAL PROPERTY (this “Release”) is made as of November 2, 2022 (“Effective Date”) in favor of ID Experts Holdings, Inc. a Delaware corporation, ID Experts Merger Sub, Inc. a Delaware corporation, and Identity Theft Guard Solutions, Inc. a Delaware corporation (“Grantors”) by Escalate Capital Partners SBIC III, LP, a Delaware limited partnership, (the “Lender”).

WHEREAS, Grantors and Lender entered into an Intellectual Property Security Agreement dated August 2, 2016, the “Intellectual Property Security Agreement”);

WHEREAS, pursuant to the Intellectual Property Security Agreement, Grantors granted to Lender a security interest in all of its right, title and interest in, to and under certain intellectual property identified as Intellectual Property and listed in the Intellectual Property Security Agreement, including those items set forth on Schedules A, B and C thereto (“Intellectual Property”);

WHEREAS, the Intellectual Property Security Agreement was recorded with the United States Patent and Trademark Office at various times against different properties including, with respect to trademarks, on August 15, 2016 at Reel/Frame 5855/0420, and, with respect to patents, on August 15, 2016 at Reel/Frame 039437/0421; and

WHEREAS, Grantors has paid all of its outstanding indebtedness to Lender.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Lender hereby (i) terminates the Intellectual Property Security Agreement, (ii) terminates, cancels and releases any and all security interests it has against the Intellectual Property, including all goodwill thereto, and (iii) re-assigns to Grantors any right, title and interest it may have in, to or under the Intellectual Property, including, without limitation, any goodwill associated therewith, to Grantors.


Lender shall take all further actions, and provide to Grantors, its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by Grantors, at Grantors’ sole cost and expense, to more fully and effectively effectuate the purposes of this Release.

This Release shall be governed by and construed in accordance with the laws of the State of New York and applicable federal law.
