At any time and from time to time after the date hereof, at Assignee's request and without further consideration, Assignor shall, within a reasonable time and at Assignee's sole expense, execute and deliver, and shall cause its affiliates and employees to execute and deliver, such instruments of sale, transfer, conveyance, assignment and confirmation, and take such other action, as Assignee may reasonably request to more effectively transfer, convey and assign to Assignee, and to confirm Assignee's title to, any or all of the Mark.
