**TERMINATION AND RELEASE OF
AMENDED AND RESTATED
INTELLECTUAL PROPERTY SECURITY AGREEMENT**

This Termination and Release of Amended and Restated Intellectual Property Security Agreement (this “**Termination**”), dated as of October 24, 2022, is executed by WESTERN ALLIANCE BANK, an Arizona corporation (“**Bank**”), in favor of OH MY GREEN, PBC (now known as Garten Wellbeing PBC), a Delaware public-benefit corporation (“**Grantor**”). All capitalized terms used in this Termination and not otherwise defined herein, shall have the respective meanings given to such terms in the Security Agreement (defined below).

RECITALS

A. Pursuant to that certain Amended and Restated Intellectual Property Security Agreement, dated as of October 16, 2019 (“**Security Agreement**”), executed by Grantor in favor of Bank, Grantor granted to Bank a security interest in the IP Collateral (defined below).

B. The Security Agreement was recorded with the Trademark Division of the United States Patent and Trademark Office on October 16, 2019 at Reel 6776 and Frame 0780, to evidence the security interest granted under the Security Agreement.

C. Bank agrees to terminate and release its security interest in the IP Collateral specified below.

AGREEMENT

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Bank hereby agrees as follows:

(a) Bank expressly terminates and releases all of Bank’s right, title and interest in pursuant to the Security Agreement, to and under the following (collectively, the “**IP Collateral**”):

(i) copyright rights, copyright applications, copyright registrations and like protections in each work or authorship and derivative work thereof, whether published or unpublished and whether or not the same also constitutes a trade secret, now or hereafter existing, created, acquired or held (collectively, the “**Copyrights**”), including the registered Copyrights described in Exhibit A;

(ii) trademark and servicemark rights, whether registered or not, applications to register and registrations of the same and like protections, and the entire goodwill of the business of Grantor connected with and symbolized by such trademarks (collectively, the “**Trademarks**”), including the registered Trademarks described in Exhibit B;

(iii) patents, patent applications and like protections including without limitation improvements, divisions, continuations, renewals, reissues, extensions and continuations-in-part of the same (collectively, the “**Patents**”), including the Patents described in Exhibit C;

(iv) mask work or similar rights available for the protection of semiconductor chips or other products (collectively, the “**Mask Works**”);

(v) trade secrets, and any and all intellectual property rights in computer software and computer software products;

(vi) design rights;

(vii) claims for damages by way of past, present and future infringement of any of the rights included above, with the right, but not the obligation, to sue for and collect such damages for said use or infringement of the intellectual property rights identified above;

(viii) licenses or other rights to use any of the Copyrights, Patents, Trademarks, or Mask Works, and all license fees and royalties arising from such use to the extent permitted by such license or rights;

(ix) amendments, renewals and extensions of any of the Copyrights, Trademarks, Patents, or Mask Works; and

(x) proceeds and products of the foregoing, including without limitation all payments under insurance or any indemnity or warranty payable in respect of any of the foregoing.


(b) Bank represents and warrants that it has the full power and authority to execute this Termination.

(c) Bank authorizes and requests the Trademark and Patent Divisions of the United States Patent and Trademark Office and the United States Copyright Office to record this Termination.
