NOW, THEREFORE, for valuable consideration, wherein the receipt and sufficiency of such valuable consideration are hereby acknowledged, Assignor hereby, sells, assigns, transfers, conveys and delivers to Assignee, all of her right, title and interest in, to and under the Assigned Trademark, together with any goodwill in connection with any use of the same, together with and all rights, powers and privileges of any kind or nature belonging thereto or incident or appurtenant thereto, including, without limitation, all reissues, renewals and extensions thereof and applications relating thereto, the right to claim priority therefor, the right to sue in respect of all infringements of the Assigned Trademarks, which may have occurred before the effective date of this Agreement, the right to all remedies including recovery damages (including past damages), an accounting of profits, or other proceeds in respect of such infringements, and all other rights, privileges and powers with respect to the Assigned Trademark, the same to be held and enjoyed by Assignee, its successors and assigns, as fully and entirely as the same would have been held and enjoyed by Assignor if this Trademark Assignment had not been made.






