## **RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENT**

THIS RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENT dated as of October 31, 2022 (this “Release”) is made by and between Banc of California, N.A., as successor in interest to Pacific Mercantile Bank (“Lender”), and Applied Membranes, Inc., a California corporation (“Grantor”). Lender and Grantor may be referred to herein individually as a “Party” or collectively as the “Parties”.

### RECITALS

A. Pursuant to the Intellectual Property Security Agreement dated September 20, 2016, by Grantor in favor of Lender (as amended, supplemented or modified and in effect from time to time, the “Intellectual Property Security Agreement”), which was recorded in the records of the United States Patent and Trademark Office at reel 040172, frame 0250 of the patent assignment database, and at reel 5561, frame 0134 at the trademark assignment database Grantor granted to Lender a security interest in Grantor’s entire right, title and interest in and to the trademark registrations and applications for trademark registration and the patent registrations and applications for patent registration set forth on SCHEDULE 1 attached hereto (the “IP Collateral”);

B. Lender wishes to release and terminate its liens, security interests and encumbrances in the IP Collateral; and

C. Grantor has requested and Lender has agreed to provide a document suitable for recording in the United States Patent and Trademark Office evidencing and effecting such release and termination.

### AGREEMENT

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the parties do hereby agree as follows:

1. Lender hereby releases and terminates all of its liens, security interests and encumbrances in the IP Collateral arising pursuant to the Intellectual Property Security Agreement.
2. Lender will, and hereby does, authorize and request the Commissioner of Patents and Trademarks of the United States of America to note and record the existence of the release and termination hereby given.
3. All other provisions contained in the Intellectual Property Security Agreement are hereby terminated. Grantor releases Lender from any and all claims arising out of the Intellectual Property Security Agreement.
