WHEREAS, the Assignor wishes to sell and assign, and Assignee wishes to purchase and assume, the Trademarks;


NOW, THEREFORE, for good and valuable consideration, the full receipt and sufficiency of which are hereby acknowledged, the parties hereto agree as follows:

Assignor further grants to Assignee the right to recover damages and all other relief for all infringements of the Trademark that have occurred prior to the date of this Assignment with the right to sue for and collect the same, for Assignee’s own use and enjoyment and for the use and enjoyment of its successors, assignees or other legal representatives, free and clear of all liens, claims, charges, security interests, and other encumbrances.
3. Assignor will promptly do and perform, or cause to be done and performed, any further acts and things, and will execute and deliver all other agreements, certificates, instruments, and documents as Assignee may request in order to carry out the intent and accomplish the purpose of this Assignment and confirm, perfect, or record the rights transferred hereby.


