ASSIGNMENT OF TRADEMARKS

THIS ASSIGNMENT OF TRADEMARKS (this "Assignment"), is made as of 11:59 p.m. on August 31, 2022 between Emmis Indiana Broadcasting, L.P. ("Assignor") and Radio One of Indiana, L.P. ("Assignee").

This Assignment is made pursuant to that certain Asset Purchase Agreement (the "Purchase Agreement") dated June 13, 2022 among Assignor and certain of its Affiliates and Assignee and certain of its Affiliates with respect to the following radio stations:

WYXB-FM, Indianapolis, Indiana (FIN 51432)
WLHK-FM, Shelbyville, Indiana (FIN 19522)
WIBC-FM, Indianapolis, Indiana (FIN 19524)
W228CX, Indianapolis, Indiana (FIN 150595)
W298BB, Indianapolis, Indiana (FIN 155816)

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and pursuant to the Purchase Agreement, Assignor and Assignee agree as follows:

Assignor does hereby sell, assign and transfer unto Assignee all of Assignor's right, title, and interest in and to, and Assignee does hereby accept and assume, the federal and state trademark registrations set forth in Exhibit A to this Assignment (collectively, the "Trademarks"), together with the goodwill of the Stations' business symbolized by the Trademarks, as well as, to the extent attributable to the period after Closing, any and all claims, demands, causes of action, rights to sue or other rights occasioned from or because of infringement of such Trademarks and the right to collect damages therefore. The parties further agree that upon request, each shall execute any and all documents reasonably necessary to give effect to the assignment and assumption contemplated hereby.

This Assignment is made pursuant to (and does not modify) the Purchase Agreement, which contains certain representations, warranties and covenants regarding the Trademarks. In the event of any conflict or inconsistency between the terms of the Purchase Agreement and the terms hereof, the terms of the Purchase Agreement shall govern. Capitalized terms used herein and not defined shall have the respective meanings set forth in the Purchase Agreement. This Assignment shall be governed by and construed in accordance with the internal laws of the State of Delaware without regard to any choice or conflicts of law provision or rule (whether of the State of Delaware or any other jurisdiction).

This Assignment may be signed in separate counterparts with the same force and effect as if all signatures appeared on one and the same instrument. Delivery of an executed signature page of this Assignment by facsimile or other electronic transmission shall be effective as delivery of a manually executed original signature page of this Assignment.




