Trademark Assignment

WHEREAS, Assignee desires to acquire the entire right, title, and interest in and to said Trademark Rights, together with the goodwill associated therewith.

Assignment

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor hereby sells, assigns, transfers, conveys, and delivers to Assignee and its successors and assigns, Assignor’s entire right, title, and interest in and to the Trademark Rights, together with the goodwill associated therewith, and any and all accounts, contract rights, warranties, infringement claims, other litigation claims and rights, including the right to sue for and collect upon all claims for profits and damages as a result of past infringement or any other claims, if any, and other general intangibles of Assignor to any of the Trademark Rights.




