TRADEMARK ASSIGNMENT

1. Assignor hereby assigns to Assignee all right, title and interest in, to, and under the Trademark,, together with the goodwill associated therewith. This assignment is made in connection with the transfer of the business to which the Trademark pertains.
2. Assignor further grants to Assignee the right to recover damages and all other relief for all infringements of the Trademark that have occurred prior to the date of this Assignment with the right to sue for and collect the same, for Assignee’s own use and enjoyment and for the use and enjoyment of its successors, assignees or other legal representatives, free and clear of all liens, claims, charges, security interests, and other encumbrances.
3. Assignor will promptly do and perform, or cause to be done and performed, any further acts and things, and will execute and deliver all other agreements, certificates, instruments, and documents as Assignee may request in order to carry out the intent and accomplish the purpose of this Assignment and confirm, perfect, or record the rights transferred hereby.
