ASSIGNMENT OF TRADEMARK SECURITY AGREEMENT

Assignee has not assumed any of the obligations or liabilities of Assignor under the Trademark Security Agreement that arose prior to the Effective Date, which obligations and liabilities remain vested in Assignor.

THIS ASSIGNMENT SHALL BE GOVERNED BY AND CONSTRUED IN ACCORDANCE WITH THE LAWS OF THE STATE OF CALIFORNIA AND THE APPLICABLE FEDERAL LAWS OF THE UNITED STATES OF AMERICA, WITHOUT REGARD TO ANY CONFLICT OF LAWS PRINCIPLES THAT WOULD RESULT IN THE APPLICATION OF THE LAWS OF ANOTHER JURISDICTION.

Any party delivering an executed counterpart of this Assignment by facsimile or by electronic mail in PDF shall also deliver a manually executed counterpart of this Assignment, but failure to do so shall not affect the validity, enforceability or binding effect of this Assignment, and each party hereby waives any right it may have to object to said treatment.
