SECOND: The name of the corporation being merged into the Surviving Entity is Spear Technologies, Inc. The jurisdiction in which this corporation was formed is California.

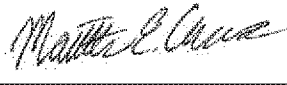
