**RELEASE OF SECURITY INTEREST IN TRADEMARKS**

This **RELEASE OF SECURITY INTEREST IN TRADEMARKS** (this "Release"), dated as of November 18, 2022, is made by **WELLS FARGO BANK, NATIONAL ASSOCIATION** ("Lender") in favor of **METROTECH CORPORATION D/B/A VIVAX-METROTECH CORPORATION**, a California corporation ("Metrotech") and **VXMT CORPORATION**, a Delaware corporation ("VXMT") and together with Metrotech, individually and collectively, jointly and severally, "Grantor").

**WHEREAS**, pursuant to that certain Trademark Security Agreement, dated June 5, 2019 (the "Trademark Agreement") between Lender and Grantor, Grantor granted to Lender a security interest in certain Trademarks (as defined in the Trademark Agreement) and other Trademark Collateral (as defined in the Trademark Agreement) of the Grantor, which Trademarks are more fully identified on Schedule I annexed hereto and made a part hereof (the "Subject Trademarks").

**WHEREAS**, Lender's security interest was recorded with the United States Patent and Trademark Office ("USPTO") by Lender's filing of the Trademark Agreement which was recorded with the USPTO on June 13, 2019, at Reel/Frame 6669/0168.

**NOW THEREFORE**, Lender hereby absolutely, unconditionally, and irrevocably releases, terminates and discharges the Trademark Agreement and Lender's security interest in, lien on, and conditional assignment of the Subject Trademarks and other Trademark Collateral and Lender hereby reassigns to the applicable Grantor any and all such right, title and interest (if any) that the Lender may have in the Subject Trademarks. Lender hereby authorizes the recordation of this Release with the USPTO. Lender agrees to cooperate with the Grantor and to provide the Grantor with the information and additional authorization reasonably required or desirable to effect the release of the Lender's security interest in the Subject Trademarks and the termination of the Trademark Agreement. This Release shall be governed by and construed in accordance with the laws of the State of California.
