
ARTICLES OF ENTITY CONVERSION

 - k. This corporation accepts the protection against liability of directors and officers.

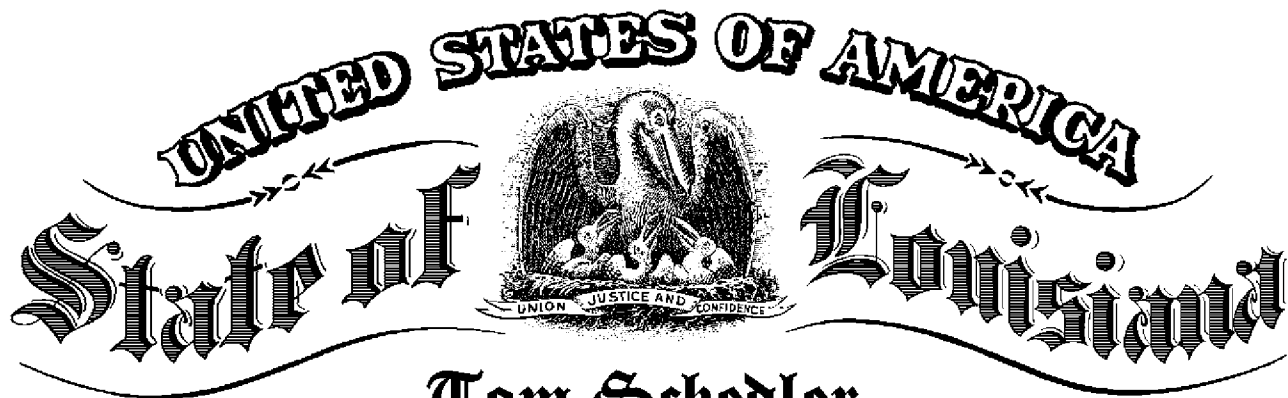
