RELEASE OF SECURITY INTEREST IN SPECIFIED TRADEMARKS

This **RELEASE OF SECURITY INTEREST IN SPECIFIED TRADEMARKS** (this “Release”), dated as of November 23, 2022, is made by **CAPITAL ONE, NATIONAL ASSOCIATION**, as Administrative and Collateral Agent (“Grantee”), in favor of **GREEN RIVER SPIRITS COMPANY, LLC**, a South Carolina limited liability company (formerly known as Green River Spirits Company) (the “Grantor”).

WHEREAS, pursuant to the terms and conditions of that certain (i) Security Agreement dated as of February 28, 2022 (as supplemented by that certain Security Agreement Supplement, dated as of July 13, 2022, and as further amended, restated, amended and restated, supplemented or otherwise modified from time to time, the “Security Agreement”, by and among the Grantor and the other grantors party thereto and the Collateral Agent for the Secured Parties pursuant to which the Grantor granted a security interest to the Collateral Agent and (ii) that certain Trademark Security Agreement executed as of July 13, 2022 (the “Trademark Security Agreement”), the Grantor granted to Grantee for the ratable benefit of the Secured Parties a continuing security interest in and continuing lien upon, and a right of set off against, any and all right, title and interest of the Grantor in and to the trademarks, trademark licenses and trademark applications shown on Schedule 1 attached hereto (collectively, the “Released Trademarks”); and

WHEREAS, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office on July 13, 2022, at Reel 7785 Frame 0863.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Grantee hereby releases, without any representation, recourse or undertaking by Grantee, any and all liens on and security interests in the Released Trademarks. This Release is applicable only and solely with respect to the Released Trademarks and to no other Trademark Collateral (as defined in the Trademark Security Agreement) arising under the Trademark Security Agreement. The Grantee retains all security interests, liens, rights, titles and interests pledged and granted to the Grantee under the Trademark Security Agreement with respect to all such other Trademark Collateral, and the Grantee’s security interest, liens, rights, titles and interests in such other Trademark Collateral shall not, and shall not be deemed to, be impaired, interrupted or otherwise modified in any respect by this Release.

Recordation of Release. The Grantee authorizes the United States Patent and Trademark Office and any other applicable governmental authority to record this Release.

Governing Law. This Release shall be governed by and construed in accordance with the laws of the State of New York.
