Release of Security Interest in Intellectual Property

This Release of Security Interest in Intellectual Property, dated as of November 23, 2022 (the “Release”), is made by The Toronto-Dominion Bank, as agent and with offices at 66 Wellington Street West, 9th Floor, Toronto, ON M5K 1A2, Canada (in such capacity, the “Agent”) in favor of Go Solar Power LLC, a Florida limited liability company with an address at 1840 N. Greenville Avenue, Suite 128, Richardson, TX 75081 (the “Grantor”).

WHEREAS, by (i) that certain Joinder Agreement, dated as of February 11, 2022 in favor of Agent (as amended, restated, or modified from time to time, the “Joinder Agreement”) and (ii) that certain related Confirmation of Security Interest in Intellectual Property, dated as of February 11, 2022 in favor of Agent (as amended, restated, or modified from time to time, the “IP Security Agreement”); capitalized terms used herein but not otherwise defined herein have the meanings given to them in the Joinder Agreement or IP Security Agreement, as applicable), which IP Security Agreement was recorded with the United States Patent and Trademark Office on February 11, 2022 at Reel 7631, Frame 0449, the Grantor granted to Agent a security interest in and to the trademarks set forth in Schedule I hereto, and the underlying goodwill associated with such trademarks (collectively, the “Trademarks”);

WHEREAS, the Grantor desires Agent to release, discharge, terminate and cancel its lien on and security interest in the Trademarks;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Agent does hereby release, discharge, terminate and cancel any and all of its right, title and interest in and to the Trademarks, including any and all goodwill relating to the same, and assigns, transfers and conveys to Grantor any and all of its rights, title and interests in and to the Trademarks, including any and all goodwill relating to the same.


The Agent authorizes and requests that the Commissioner for Trademarks and any other applicable government officer record this Release.
