TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS

This TERMINATION OF SECURITY INTEREST IN TRADEMARKS (“*Release*”), dated as of October 3, 2022, is made by CAMBRIDGE SAVINGS BANK (“*Secured Party*”) in favor of STANCHEM INCORPORATED (the “*Grantor*”). All capitalized terms used but not otherwise defined herein have the respective meanings ascribed to such terms in the Security Agreement (as defined below).

WHEREAS, the Grantor entered into a certain Trademark Security Agreement dated on or about July 21, 2017 (the “*Security Agreement*”), between the Grantor and the Secured Party, pursuant to which Grantor, to secure the prompt and complete repayment and performance of the obligations of the Grantor to the Secured Party under a certain Credit Facilities Agreement dated July 21, 2017, pledged and granted to the Secured Party, a security interest in all of such Grantor’s right, title and interest in, to and under the Trademark Collateral, including without limitation the trademarks included on Schedule I thereto;

WHEREAS, the Security Agreement was recorded in the United States Patent and Trademark Office on July 21, 2017, at Reel 6116, Frame 0626;

WHEREAS, the Secured Party desires to release its security interest in the Trademark Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Secured Party hereby agrees as follows:


1. The Secured Party, without any recourse, representation or warranty, hereby terminates, releases and discharges any and all liens and security interests of the Secured Party in the Trademark Collateral, including, without limitation, the trademarks included on Exhibit A hereto, if any, and any right, title or interest of the Secured Party in, to and under the Trademark Collateral shall hereby cease and become void.

2. The Secured Party hereby authorizes and requests the Commissioner of Trademarks of the United States Patent and Trademark Office to record this Release.

3. This Release and the rights and obligations of the parties hereunder shall be governed by, and shall be construed and enforced in accordance with, the laws of the Commonwealth of Massachusetts without regard to conflict of law principles thereof.
