CORRECTIVE ASSIGNMENT AGREEMENT

THIS CORRECTIVE ASSIGNMENT AGREEMENT (“Agreement”), dated December 7, 2022, is hereby entered into by and between The Neiman Marcus Group, LLC, a Delaware limited liability company (formerly known as The Neiman Marcus Group, Inc., a Delaware corporation) having a principal place of business at 1618 Main Street, Dallas, Texas 75201 (“Assignor”) and NM Nevada Trust, a Massachusetts trust having a principal place of business at 3200 Las Vegas Boulevard, Las Vegas, Nevada 89109 (“Assignee”).

RECITALS

WHEREAS, on January 23, 2012 (“Assignment Date”), The Neiman Marcus Group, Inc. (as predecessor to Assignor) and Assignee executed an Assignment (“Prior Assignment”), assigning all of Assignor’s right, title and interest, in, to and under various trademarks, including the trademark registrations and applications listed on Exhibit A attached hereto, including but not limited to all common law rights therein, all applications and registrations therefor and the goodwill of the business associated with said marks (collectively, the “Marks”);

WHEREAS, the Prior Assignment was recorded with the United States Patent and Trademark Office on January 23, 2012, at Reel 4702 Frame 0850, and is attached as Exhibit B;

WHEREAS, in the Prior Assignment, Assignee was mistakenly designated as a “Massachusetts corporation,” when in fact Assignee was and has been since at least as early as the Assignment Date, a Massachusetts trust, and no such Massachusetts corporation entity ever existed, including on the Assignment Date;

WHEREAS, Assignor and Assignee desire to correct the error in designating Assignee’s entity form in the Prior Assignment and also to confirm the assignment of the Marks from Assignor’s predecessor to Assignee;

NOW THEREFORE, in consideration of the recitals, the terms and conditions herein, the amount of Ten Dollars (\$10.00) and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties, intending to be legally bound, hereby agree as follows:

1. **Assignment**. Assignor does hereby confirm that it sold, assigned, and transferred to Assignee, its successors and assigns, all of its right, title, and interest, in the United States of America and all other countries, in, to and under the Marks, including any and all goodwill associated therewith, all registrations therefore, all common law rights therein, any and all trademark and/or service mark rights related thereto, and all past, present and future income, royalties, fees, damages, and payments now or hereafter due or payable in respect thereto, and in and to any and all past, present and future causes of action (either in law or in equity), and the right to enforce any rights and file any causes of action, including the right to recover damages, for any past, present, or future infringement or misappropriation of the Marks.

2. **Miscellaneous.** Assignor hereby agrees to execute, acknowledge and deliver any and all documents as Assignee, in its discretion deems desirable or necessary to make a record with any and all government agencies, authorities, courts, tribunals, or third parties, of the fact that Assignee owns all right, title and interest in and to the Marks, and any and all goodwill associated therewith, and that Assignor no longer has any right, title or interest, of any kind or nature, in or to the Marks.

3. **Counterparts.** This Agreement may be executed in original, facsimile or electronic counterparts, including portable document format (PDF) and secure electronic signature (such as DocuSign), each of which will be deemed an original, and which when taken together will constitute one and the same instrument.

WHEREFORE, Assignor and Assignee have caused this Corrective Assignment Agreement to be duly executed below, on the date indicated.


