**TERMINATION AND RELEASE OF SECURITY INTEREST IN
TRADEMARK SECURITY AGREEMENT**

THIS TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT, dated as of November 23, 2022, is made by CAPITAL ONE, NATIONAL ASSOCIATION (“Agent”) in favor of Avantus Federal LLC (formerly known as E3 Federal Solutions, LLC), a Virginia limited liability company (“Grantor”).

WHEREAS, pursuant to the Guaranty and Security Agreement, dated as of December 6, 2019, by and among Grantor, Agent, and the other grantors party thereto, Grantor granted a first priority security interest to the Agent in and to the Trademark Collateral (as defined in the IP Security Agreement), including all of Grantor’s now owned or existing trademarks, including as set forth on Schedule 1 attached hereto (the “Trademarks”); and

WHEREAS, the Agent executed a Trademark Security Agreement, dated as of September 2, 2020 (the “IP Security Agreement”), which was duly recorded on September 2, 2020 at Reel 7042 Frame 0365 in the United States Patent and Trademark Office; and

WHEREAS, the Agent, in its capacity as administrative agent, wishes to release and restore all right, title and interest in and to the Trademark Collateral to the Grantor and to dissolve those liens and encumbrances created by the IP Security Agreement.

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the Agent does hereby, in each case, without recourse, representation or warranty of any kind whatsoever, (a) terminate the liens and security interest created under the IP Security Agreement in the Trademark Collateral, (b) terminate and release its security interest in the Trademark Collateral, and (c) discharge any and all rights, title and interest it has in and the security interest granted to Agent in the Trademark Collateral.
