GRANT OF SECURITY INTEREST

(Trademarks)

THIS GRANT OF SECURITY INTEREST, dated as of October 20, 2022 is executed by SPORT OBERMEYER LTD., a Colorado corporation ("Borrower"), in favor of U.S. BANK NATIONAL ASSOCIATION, a national banking association ("Bank").

A. Pursuant to that certain Loan and Security Agreement dated as of the date hereof, by and among Borrower, the other Credit Parties thereto and Bank, as the same may from time to time be amended, modified, extended, renewed, supplemented or restated (the "Loan Agreement"), Bank has agreed to extend certain credit facilities to Borrower upon the terms and subject to the conditions set forth therein.

B. Borrower has adopted, used and are using the inventions describe and claimed in the trademarks and trademark applications described on Schedule A annexed hereto and made a part hereof, which trademarks and trademark applications are pending or registered in the United States Patent and Trademark Office (collectively, the "Trademarks").

C. Pursuant to the Loan Agreement, Borrower has granted to Bank a security interest in all right, title and interest of Borrower in and to, among other things, all of its trademarks, including the Trademarks, together with the goodwill of the business symbolized by the Trademarks and the applications and registrations thereof, and all proceeds thereof, including any and all causes of action which may exist by reason of infringement thereof (the "Collateral"), to secure the payment, performance and observance of the Obligations, as defined in the Loan Agreement.

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, Borrower does hereby further grant to Bank a security interest in the Collateral to secure the prompt payment, performance and observance of the Obligations.

Borrower does hereby further acknowledge and affirm that the rights and remedies of Bank with respect to the security interest in the Collateral granted hereby are more fully set forth in the Loan Agreement, the terms and provisions of which are hereby incorporated herein by reference as if fully set forth herein.
