Under Section 242 of the Delaware General Corporation Law

UTC Fire & Security Americas Corporation, Inc., a corporation organized and existing under the laws of the State of Delaware (the "Corporation"), hereby certifies that:

1. The name of the Corporation is UTC Fire & Security Americas Corporation, Inc. The Corporation's original Certificate of Incorporation was filed with the Secretary of State of the State of Delaware on December 17, 2001 under the name "Margaret Acquisition, Inc."

2. The Corporation's Restated Certificate of Incorporation is hereby amended by deleting, in its entirety, Article FIRST and inserting in place a new Article FIRST that reads as follows:
