RELEASE OF TRADEMARK SECURITY AGREEMENT

THIS RELEASE OF TRADEMARK SECURITY AGREEMENT (“Release”), dated as of October 26, 2022, is made by Wilmington Trust, National Association, as the Notes Collateral Agent for the Notes Secured Parties (as defined in the Indenture) (“Agent”), and is as follows:

WHEREAS, pursuant to that certain Indenture, dated as of February 1, 2022, among U.S. Acute Care Solutions, LLC, a Delaware limited liability company (the “Issuer”), U.S. Acute Care Solutions, Inc., a Delaware Corporation (“Holdings”), the guarantors from time to time party thereto, Agent and Wilmington Trust, National Association, as Trustee (as the same may have been further amended, restated, supplemented, or otherwise modified, the “Indenture”), Agent and Alteon Health, LLC (the “Grantor”) entered into that certain that certain First Lien Notes Trademark Security Agreement dated as of February 1, 2022 which was recorded with the United States Patent and Trademark Office at Reel 007601, Frame 0151 (the “Agreement”);

WHEREAS, the Agreement granted to Agent, for the benefit of the Secured Parties, a continuing security interest in all right, title and interest in all assets of Grantor, which assets include the Trademark Collateral as defined in the Agreement and which includes the registrations listed on Schedule I hereto; and

WHEREAS, Agent desires to release its rights and security interests in the Trademark Collateral, including each mark, registration, and application listed on Schedule I attached hereto.


NOW, THEREFORE, Agent hereby fully and finally releases and terminates without recourse, representation or warranty of any kind (i) its security interest in and to, and all other rights in, to and under the Trademark Collateral, including each mark, registration, and application listed on Schedule I attached hereto and (ii) any and all other rights it may have in the Trademark Collateral under the Agreement or the Indenture.

Wilmington Trust, National Association is executing this Release not in its individual or corporate capacity, but solely in its capacity as Notes Collateral Agent for the Secured Parties under the Indenture. In acting hereunder, Agent shall be entitled to all of the rights, privileges, immunities and indemnities granted to the Notes Collateral Agent under the Indenture as if such rights, privileges, immunities and indemnities were set forth herein.
