TRADEMARK RELEASE AND REASSIGNMENT

This Trademark Release and Reassignment is entered into as of November 30, 2022, by **WELLS FARGO BANK, NATIONAL ASSOCIATION**, a national banking association (the "Secured Party").

Laker Co., a Colorado corporation ("Grantor"), entered into an Amended and Restated Patent and Trademark Security Agreement between the Grantor and the Secured Party, dated as of January 4, 2008, pursuant to which the Grantor granted the Secured Party a security interest in the Trademark Collateral as defined therein, including the Trademarks referred to on Schedule I hereto (the "Trademark Agreement").
