**RELEASE OF SECURITY INTEREST IN TRADEMARKS**

This RELEASE OF SECURITY INTEREST IN TRADEMARKS (this “Release”), dated as of December 1, 2022 (the “Effective Date”), is made by Bank of America, N.A., in its capacity as Collateral Agent pursuant to the Credit Agreement (the “Agent”), in favor of EVERTEC Group, LLC (the “Grantor”).

WHEREAS, pursuant to that certain Collateral Agreement, dated as of November 27, 2018 by and among the Agent, the Grantor and certain other parties thereto (as amended, amended and restated, supplemented or otherwise modified from time to time, the “Collateral Agreement”), the Grantor granted to the Agent, in its capacity as Collateral Agent, a security interest in and to certain collateral;

WHEREAS, pursuant to the Collateral Agreement, the Grantor executed and delivered a U.S. Trademark Security Agreement, dated as of November 27, 2018, in favor of the Agent (the “Trademark Security Agreement”), for recordal with the United States Patent and Trademark Office;

WHEREAS, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office on November 28, 2018 at Reel/Frame 6542/0416; and

WHEREAS, the Agent now desires to release any and all security interests, and any other liens, it has in the Trademark Collateral (as defined below).

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby agrees as follows:

1. Defined Terms. The term “Trademark Collateral” means all of Grantor’s right, title and interest in, to and under: (a) all Trademarks of the Grantor, including those listed on Schedule I attached hereto and (b) all Proceeds of any and all of the foregoing. All capitalized terms used, but not otherwise defined herein, shall have the respective meanings ascribed in or otherwise referenced in the Collateral Agreement or the Trademark Security Agreement, as applicable.

2. Release. The Agent, without representation or warranty of any kind, hereby releases, discharges, terminates and cancels, for the benefit of Grantor and its successors and assigns, all of its security interest in and lien on the Trademark Collateral, arising under the Collateral Agreement and the Trademark Security Agreement, and any other security interests, liens, right, title or interest that the Agent, acting in its capacity as Collateral Agent under the Collateral Agreement and the Trademark Security Agreement, may have in, on or to the Trademark Collateral. If and to the extent that the Agent has acquired any right, title or interest in, to or under the Trademark Collateral under the Collateral Agreement or the Trademark Security Agreement, the Agent, hereby re-transfers, re-conveys and re-assigns all such right, title and interest to the Grantor.

3. Termination. The Agent acknowledges and agrees that the Trademark Security Agreement and, with respect to the Trademark Collateral, the Collateral Agreement are terminated.

4. Further Assurances. The Agent agrees to take all further actions, and provide to the Grantor and its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by the Grantor, at the Grantor’s sole cost and expense, to more fully and effectively effectuate the purposes of this Release.

5. Governing Law. This Release shall be governed exclusively under the laws of the State of New York, without regard to conflicts of law or choice of law principles.
