TRADEMARK RELEASE AND REASSIGNMENT

This Trademark Release and Reassignment is entered into as of November 30, 2022, by **WELLS FARGO BANK, NATIONAL ASSOCIATION**, a national banking association (the "Secured Party").

Laker Co., a Colorado corporation ("Grantor"), entered into a Patent and Trademark Security Agreement between the Grantor and the Secured Party, dated as of January 16, 2002, pursuant to which the Grantor granted the Secured Party a security interest in the Trademark Collateral as defined therein, including the Trademarks referred to on Schedule I hereto (the "Trademark Agreement").
