CONFIRMATORY TRADEMARK ASSIGNMENT AGREEMENT

WHEREAS, as of the Effective Date, RHI was the owner of the trademarks, trademark applications, and trademark registrations identified and listed in Schedules "A" and "B" to this Assignment Agreement (the "Marks");

AND WHEREAS, as of the Effective Date, Apollo acquired from RHI the whole right, title and interest in and to the Marks, together with the goodwill of the business carried on worldwide in association with the Marks;

NOW THEREFORE, for and in consideration of One Dollar (\$1.00 CAD), the receipt and sufficiency of which is hereby acknowledged:

1. RHI confirms and acknowledges that effective as of **January 7, 2022** (the "Effective Date") it sold, assigned, and transferred unto Apollo, its successors and assigns, the whole right, title and interest in and to the Marks, including all common law rights thereto, together with the goodwill of the business carried on worldwide in association with the Marks, the same to be held by Apollo as fully and effectually as it would have been held by RHI if this assignment and sale had not been made, together with all claims for past, present, and future damages by reason of infringement or other violation of the same, with the right to sue for past, present and future damages and collect the same for Apollo's own use and enjoyment. With respect to the transfer of the United States intent-to-use trademark applications set forth in **Schedule "B"** hereto, RHI further confirms and acknowledges that Apollo is the successor to the business of RHI, and such transfer accompanies the business, or that portion of the business, to which the listed Marks pertain, and that business is ongoing and existing.
2. RHI agrees that it will upon request, and without further consideration, do such things and execute such further documents as may be necessary or desirable to vest title in the Marks in Apollo, its successors, or its assigns.
3. RHI hereby authorizes the U.S. Commissioner for Trademarks and any other governmental officials of any country or countries foreign to the United States, to record and register this Confirmatory Trademark Assignment Agreement upon request by Apollo.
4. The laws of the Province of Ontario and Canada govern this Confirmatory Trademark Assignment Agreement with respect to the transfer of the Marks in **Schedule A**. The federal laws of the

United States and the laws of the State of Delaware govern this Confirmatory Trademark Assignment Agreement with respect to the transfer of the Confirmatory Trademark Marks in **Schedule B**. This Assignment Agreement shall inure to the benefit of, and be binding upon, the Parties hereto and their respective heirs, executors, administrators, personal representatives, successors and assigns.

5. Execution of this Confirmatory Trademark Assignment Agreement may be achieved in counterparts, each of which shall be deemed an original, but all of which together shall be deemed to be one and the same agreement. A signed copy of this Confirmatory Trademark Assignment Agreement delivered by facsimile, e-mail or other means of electronic transmission shall be deemed to have the same legal effect as delivery of an original signed copy of this Confirmatory Trademark Assignment Agreement.
