CONFIRMATION OF TRADEMARK ASSIGNMENT

"Duo Security Marks" means all of Duo Security's trademarks, service marks, trade names, trade dress, logos, designs and slogans, in word mark, stylized and/or design formats, including without limitation Duo Security's trademark registrations and applications and any and all of Duo Security's common law rights in the aforementioned items, together with all goodwill associated with and symbolized by the aforementioned items, including without limitation the marks identified in Schedule 1 attached hereto and all of the goodwill associated with and symbolized by such marks.

Effective July 26, 2020, Duo Security has assigned and transferred, and Cisco received and accepted, all of Duo Security's rights, title and interest throughout the world in and to the Duo Security Marks and all the rights, claims and privileges pertaining to the Duo Security Marks, including without limitation: the registrations and applications pertaining thereto, together with all of the goodwill of the business associated with and symbolized by the Duo Security Marks; and the right to sue and recover damages for past, present and future infringements thereof and to stand in the place of Duo Security in all matters related thereto.

Duo Security hereby authorizes and requests the United States Commissioner of Patents and Trademarks and the relevant officials of foreign jurisdictions to implement this Assignment.
