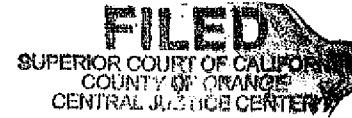

28 **ORDER GRANTING APPLICATION FOR RIGHT TO ATTACH ORDER AND ORDER FOR  
ISSUANCE OF WRIT OF ATTACHMENT AFTER HEARING**

1 Plaintiff CUE INDUSTRIES, LLC (“CUE”) application for a right to attach order and  
2 order for issuance of writ of attachment (the “Application”) against the property of Defendant  
3 ARC, LLC, which was converted to Shaiya Holding Group, LLC on July 15, 2020, (“ARC,  
4 LLC”) came on regularly for hearing on November 1, 2021 at 1:30 p.m. in Department C42 of the  
5 above-entitled court (the “Court”), the Honorable David Hoffer presiding, Michael S. LeBoff  
6 appearing on behalf of ARC, LLC, and Craig S. Robson, Corfield Feld LLP on behalf of CUE.  
7 The Court, having fully considered the arguments of all parties, both written and oral, as well as  
8 the evidence presented, now **RULES:**

9 The application of CUE for a right to attach order and issuance of a Writ of Attachment is  
10 granted in the amount of \$604,392.64. In support thereof, as required by the statutes, the Court  
11 hereby **FINDS:**

- 12 1. ARC, LLC is a limited liability company;
- 13 2. The claim upon which the application is based is one upon which an attachment  
14 may be issued;
- 15 3. CUE has established the probable validity of the claim upon which the attachment  
16 is based;
- 17 4. The attachment is not sought for a purpose other than the recovery on the claim  
18 upon which the attachment is based;
- 19 5. The amount to be secured by the attachment is greater than zero;
- 20 6. The following property is not exempt from attachment;
  - 21 a. ARC, LLC: All company/corporate property subject to attachment, where a  
22 method of levy is available.
- 23 7. An undertaking in the amount of \$10,000.00 is required, and CUE shall  
24 immediately file an undertaking in that amount.

25 Based on these findings, the Court hereby **ORDERS:**

- 26 1. CUE has a right to attach property of ARC, LLC, in the amount of \$604,392.64;
- 27 2. The clerk shall issue writs of attachment in the amount of \$604,392.64 immediately;

3. ARC, LLC shall transfer to the levying officer possession of:

a. The following property of ARC, LLC for which a method of levy is provided, specifically including:

- i. All of ARC, LLC's personal property, inventory, money, instruments, negotiable instruments of title, equipment and general intangibles located at its address: 400 Renaissance Center Dr. Detroit, MI 48243; and
- ii. Any accounts receivable and general intangibles arising out of ARC, LLC's trade or business.

4. ARC LLC, shall transfer to the levying officer possession of any documentary evidence in ARC LLC's possession of any debt owed to ARC, LLC.

**NOTICE TO DEFENDANTS: FAILURE TO COMPLY WITH THIS ORDER MAY SUBJECT YOU TO ARREST AND PUNISHMENT FOR CONTEMPT OF COURT.**
