Trademark Assignment

This TRADEMARK ASSIGNMENT AGREEMENT (this “**Assignment**”), dated as of October 31, 2022, is made by and between Emerson Electric Co., a Missouri corporation (“**Assignor**”), and Whirlpool Properties, Inc., a Michigan corporation (“**Assignee**”). Assignor and Assignee may be referred to herein individually as a “**Party**” and collectively as the “**Parties**.” Capitalized terms used but not defined in this Assignment shall have the respective meanings ascribed to them in that certain Asset and Stock Purchase Agreement by and between Emerson Electric Co. (“**Seller**”) and Whirlpool Corporation (“**Buyer**”), dated as of August 7, 2022 (the “**Purchase Agreement**”).

WHEREAS, Assignor and Assignee have entered into the Purchase Agreement pursuant to which Assignor has agreed to sell, convey, transfer, assign and deliver to Assignee the Assigned IP Assets, including the trademarks and applications for trademark registration listed on Schedule A attached hereto (collectively, the “**Assigned Trademarks**”).

NOW, THEREFORE, in consideration of the mutual promises and covenants set forth below and in the Purchase Agreement, and for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and intending to be legally bound thereby, Assignor, on behalf of itself and its Retained Subsidiaries, does hereby convey, transfer, assign and deliver to Assignee all of Assignor’s and its Retained Subsidiaries’ right, title and interest in and to (i) the Assigned Trademarks, together with all goodwill associated therewith, in each case to be held and enjoyed by Assignee for its own use and enjoyment as fully and entirely as the same would have been held and enjoyed by Assignor if this assignment and sale had not been made, and (ii) all rights to sue, claim and recover for past, present and future infringement, dilution or other violations of any Assigned Trademark.

This Assignment includes assignment to Assignee of the right to make application in its own behalf for protection of the Assigned Trademarks and any trademarks registered on the Assigned Trademarks, in the United States and countries foreign to the United States, and under any international arrangements or treaties. Assignor hereby authorizes and requests the Commissioner for Trademarks to record this Assignment and that all U.S. trademarks with respect to the Assigned Trademarks shall register to Assignee.

This Assignment may be executed in counterparts, each of which shall be deemed an original, but all of which together shall be deemed to be one and the same agreement.

Nothing in this Assignment, express or implied, is intended to or shall be construed to modify, expand or limit in any way the provisions of the Purchase Agreement. In the event of any conflict, ambiguity or inconsistency between any provision of this Assignment and any provision of the Purchase Agreement, the applicable provision of the Purchase Agreement shall be deemed to be controlling.
