**TERMINATION AND RELEASE OF SECURITY INTEREST**

This **TERMINATION AND RELEASE OF SECURITY INTEREST**, dated as of August 31, 2022 ("Release"), is made by TWIN BROOK CAPITAL PARTNERS, LLC ("Agent"), in favor of NATIONAL TRUCK PROTECTION CO., INC., a New Jersey corporation ("NTP") and AMERICAN TRUCK PROTECTION, LLC ("ATP"). ATP and NTP are referred to herein individually as a "Grantor" and together, the "Grantors").

**WHEREAS**, Agent, NTP, and certain other parties have entered into that certain Guaranty and Collateral Agreement, dated as of July 25, 2016 (as from time to time amended, restated, supplemented or otherwise modified, the "Security Agreement");

**WHEREAS**, pursuant to that certain Trademark Security Agreement, dated as of July 25, 2016, by and between Agent and NTP (the "IP Security Agreement"), NTP granted to Agent, to secure its obligations under the Security Agreement, a continuing security interest in all right, title and interest of Grantors in and to certain Intellectual Property;

**WHEREAS**, the IP Security Agreement was recorded at the United States Patent and Trademark Office ("USPTO") on July 28, 2016 at Reel 5844 Frame 0159; and

**WHEREAS**, Grantors have satisfied the terms of the IP Security Agreement and request a specific release of the security interest granted and recorded against its Intellectual Property.

**NOW THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Agent hereby agrees as follows:

**SECTION 1. Defined Terms.** All capitalized terms used herein but not otherwise defined herein have the meanings given to them in the IP Security Agreement.

**SECTION 2. Termination and Release.** Agent, without representation, warranty, or recourse, hereby:

(a) terminates the IP Security Agreement and terminates, cancels, discharges, and releases all of its security interests in and to all right, title and interest of Grantors in and to all Intellectual Property (including, but not limited to, all Collateral under the IP Security Agreement, including, but not limited to, the Trademark Collateral), whether granted pursuant to the IP Security Agreement or otherwise (and including, but not limited to, the Trademarks listed on Schedule A attached hereto);

(b) assigns and transfers to Grantors all of its right, title and interest in and to all Intellectual Property, whether granted pursuant to the IP Security Agreement or otherwise (including, but not limited to the Trademarks listed on Schedule A attached hereto), together with the goodwill of the business symbolized thereby; and


(c) authorizes the recordation of this Release with the USPTO or any similar office or agency within or outside the United States at the Grantor's expense.

**SECTION 3. Choice of Law.** This Release shall be governed by and construed in accordance with the laws of the State of New York.
