RELEASE OF TRADEMARK SECURITY AGREEMENT

THIS RELEASE OF TRADEMARK SECURITY AGREEMENT (“Release”), dated as of September 27, 2022, is made by **FIFTH THIRD BANK, NATIONAL ASSOCIATION**, formerly known as Fifth Third Bank, as Agent for the benefit of the Lenders (“Agent”), and is as follows:

WHEREAS, **UMA ENTERPRISES, INC.**, a California corporation (“Grantor”), and Agent are parties to that certain Security Interest Grant, dated as of June 6, 2014, which was recorded with the United States Patent and Trademark Office on June 23, 2014 in its records at Reel 5308, Frame 0038 (the “Agreement”); capitalized terms used but not defined herein will have the meaning given to them in the Agreement;

WHEREAS, the Agreement granted to Agent, for the benefit of the Lenders, a continuing security interest in all right, title and interest in all assets of Grantor, which assets include trademarks, service marks, and the applications and registrations thereof including each mark, registration, and application listed on Schedule I of the Agreement (attached hereto and made a part hereof as Schedule I), and all proceeds thereof, including, without limitation, any and all causes of action which may exist by reason of infringement thereof and any and all damages arising from past, present, and future violations thereof (the “Trademark Collateral”); and


WHEREAS, Agent desires to release its rights and security interests in the Trademark Collateral, including each mark, registration, and application listed on Schedule I attached hereto.

NOW, THEREFORE, Agent hereby fully and finally releases and terminates (i) its security interest in and to, and all other rights in, to and under the Trademark Collateral, including each mark, registration, and application listed on Schedule I attached hereto and (ii) any and all other rights it may have under the Agreement.


