2. Further Assurances. Assignor shall execute and deliver after the date hereof such further certificates, agreements and other documents and take such other actions as Assignee may reasonably request in order to carry out the intent and accomplish the purposes of this Trademark Assignment. Such actions may include Assignor's obtaining and recording any necessary documentation to the extent reasonably required to demonstrate a complete chain of title with respect to the Assigned Trademarks.

3. Governing Law. This Trademark Assignment will be construed in accordance with, and this Trademark Assignment and any disputes or controversies related hereto will be governed by, the laws of the State of Delaware without giving effect to any conflicts of laws principles thereof that would apply the laws of any other jurisdiction.

4. Counterparts. This Trademark Assignment may be executed in any number of counterparts, each of which when executed and delivered shall constitute a duplicate original, and all counterparts together shall constitute a single agreement.

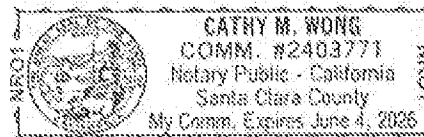

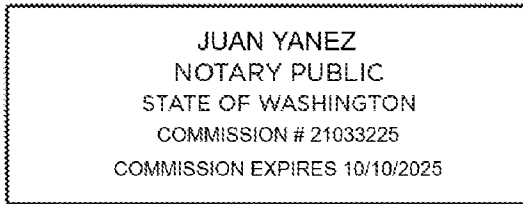
