**PARTIAL TERMINATION AND RELEASE OF  
TRADEMARK COLLATERAL ASSIGNMENT AND SECURITY AGREEMENT**

THIS PARTIAL TERMINATION AND RELEASE OF TRADEMARK COLLATERAL ASSIGNMENT AND SECURITY AGREEMENT (“Release”) is made as of this 25th day of October 2022, by WELLS FARGO CAPITAL FINANCE, LLC, a Delaware limited liability company, in its capacity as agent (“Agent”), in favor of GEDNEY FOODS COMPANY (f/k/a M.A. Gedney Company), a Minnesota corporation, (“Grantor”).

WHEREAS, Grantor entered into a certain Trademark Collateral Assignment and Security Agreement, dated June 23, 2014, with Agent, notice of which was recorded with the United States Patent and Trademark Office on December 30, 2014, at reel/frame 005460/0508, and on October 22, 2015 at reel/frame 005650/0898, (the “Security Agreement”). Capitalized terms used but not otherwise defined herein have the meanings given to them in the Security Agreement.

WHEREAS, Grantor granted to Agent, under the terms of the Security Agreement, a security interest in favor of Agent, in and to all of their right, title and interest in and to the Trademarks, including without limitation the Trademarks listed in Schedule 1 attached hereto (the “Trademarks”).

WHEREAS, Agent has agreed to terminate and release its security interest in all such Trademarks as herein provided. Agent’s security interest in all other trademarks as described in the Security Agreement remain in full force and effect.

FOR GOOD AND VALUABLE CONSIDERATION, the receipt and adequacy of which are hereby acknowledged, Agent hereby releases, terminates and discharges its security interest in the Trademarks listed on the schedule attached hereto and made a part hereof, and

assigns, transfers and conveys to Grantor any interest in such Trademarks, including the security interest.
