

2. Assignor agrees to execute any additional documents and to take such other actions as may be necessary to transfer to Assignee its entire right, title and interest in and to the Assigned Trademark.

3. The assignment set forth in paragraph 1 of this Assignment is subject to all licenses, options to acquire licenses, and other rights in and to the Assigned Trademark previously granted to any third person, which grants are in effect as of the date of this Assignment.
4. The parties hereto authorize and request the Commissioner of Patents and Trademarks of the United States to record Assignee as the assignee and owner of the Assigned Trademark.
5. This Assignment shall be governed by and construed in accordance with the laws of the State of New York without regard to the conflicts of law principles thereof.
6. All capitalized terms not otherwise defined in this Assignment, as used in this Assignment, will have the respective meanings set forth in the Agreement.
