FIRST. The name of this corporation is SYNEOS HEALTH CLINICAL, INC."

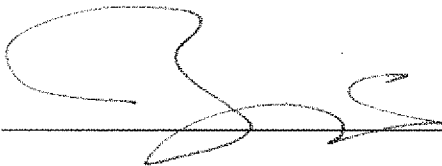
