**TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT**

**THIS TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT** (this "Termination"), is dated as of November 3, 2022, and made by **BALANCE POINT CAPITAL PARTNERS II, L.P.** (the "Grantee") to **VITADEPOT.COM, LLC**, a Florida limited liability company (the "Grantor").

WHEREAS, pursuant to (i) that certain Term Loan Credit and Security Agreement dated as of May 19, 2020 (the "Credit Agreement") by and among the Grantor, the other Loan Parties party thereto and Grantee and (ii) that certain Trademark Security Agreement dated as of February 16, 2021 (the "Security Agreement") made by Grantor in favor of Grantee, a security interest and continuing lien on all of Grantor's right, title and interest in, to and under the Collateral (as defined in the Credit Agreement), including without limitation, Trademark Collateral (as defined in the Security Agreement), was granted by the Grantor to Grantee;

WHEREAS, the Security Agreement was recorded with the trademark division of the United States Patent and Trademark Office on February 16, 2021 at Reel/Frame 7193/0629;


WHEREAS, Grantee now desires to terminate the Security Agreement and terminate, release and discharge its security interest in the Trademark Collateral listed on Exhibit A hereto;

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination, Grantee hereby terminates the Security Agreement and terminates, releases and discharges its security interest in the Trademark Collateral and reassigns to the person or persons legally entitled thereto all right, title and interest of Grantee in the Trademark Collateral.
