RELEASE OF SECURITY INTEREST TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS dated December 8, 2022 by BMO Harris Bank N.A. a national banking association ("*BMO Harris*"), with its mailing address at 111 West Monroe Street, Chicago, Illinois 60603, acting as administrative agent hereunder for the Secured Creditors as defined in the Security Agreement as defined in the Trademark Collateral Agreement referred to below (BMO Harris acting as such administrative agent being hereinafter referred to as the "*Agent*");

WITNESSETH:

(ii) all proceeds of the foregoing, including without limitation (x) any and all royalties, fees, income, payments and other proceeds now or hereafter due or payable with respect to any and all of the foregoing and (y) any and all claims and causes of action by Debtor against third parties for damages, restitution and injunctive and other legal and equitable relief by reason of past, present or future infringement, dilution, misappropriation, violation, misuse, breach or default of any trademark, trademark registration, or trademark application listed on Schedule A hereto or by reason of injury to the goodwill associated with any such trademark, trademark registration, or trademark application, in each case together with the right but no obligation to sue for and collect, or otherwise recover, said damages.
