PARTIAL RELEASE OF SECURITY INTEREST IN TRADEMARKS

This PARTIAL RELEASE OF SECURITY INTEREST IN TRADEMARKS, dated as of November 23 2022 (this “Release”) is made by MANUFACTURERS AND TRADERS TRUST COMPANY, as administrative agent (in such capacity, together with its successors and permitted assigns, the “Administrative Agent”) in favor of STANDARD LOCKNUT, L.L.C., a Missouri limited liability company (the “Grantor”).

1.

Pursuant to that certain Security and Pledge Agreement, dated as of October 7, 2019 (as amended, restated, supplemented or otherwise modified from time to time, the “Security Agreement”), by the Grantor, each other grantor party thereto, and the Administrative Agent, the Grantor, each other grantor party thereto and the Administrative Agent entered into a certain Notice of Grant of Security Interest in Trademarks, dated as of October 7, 2019 and recorded in the United States Patent and Trademark Office on October 8, 2019, at Reel 6766, Frame 0565 (the “Trademark Security Agreement”), and pursuant to the Security Agreement, the Grantor granted to the Administrative Agent a continuing security interest in and continuing lien upon the trademark registrations, together with the goodwill of the business connected with the use of and symbolized by the trademarks and all proceeds thereof, including, without limitation, any and all past, present and future causes of action which may exist by reason of infringement thereof, including without limitation, any past, present and future causes of action which may exist by reason of infringement thereof, shown on Schedule A attached hereto (collectively, the “Specified Trademarks”).

2.

The Administrative Agent, without representation, warranty or recourse of any sort, hereby terminates, releases and discharges the security interest in and lien upon the Specified Trademarks granted pursuant to the Security Agreement and the Trademark Security Agreement. For the avoidance of doubt, no other lien or security interest in any intellectual property or any other asset of the Grantor (other than the Specified Trademarks) granted to the Administrative Agent pursuant to the Security Agreement, the Trademark Security Agreement or otherwise shall be released hereby.

3.

The Administrative Agent hereby agrees to duly execute, acknowledge, procure and deliver any further documents and to do such other acts as may be reasonably necessary and requested by the Grantor to effect the release of the security interest contemplated hereby, at the Grantor’s expense. The Administrative Agent hereby authorizes the Grantor or the Grantor’s authorized representative to record this Release with the United States Patent and Trademark Office.

4.

This Release may be executed in any number of counterparts, each of which when so executed shall be deemed to be an original and all of which taken together shall constitute one and the same agreement. Delivery by telecopier or by electronic .pdf copy of an executed counterpart of a signature page to this Release shall be effective as delivery of an original executed counterpart of this Release.


