TRADEMARK ASSIGNMENT

This TRADEMARK ASSIGNMENT (this “Assignment”) is made by and between Trippe Manufacturing Company, an Illinois corporation, located at 1111 W. 35th Street, Chicago, Illinois 60609, U.S.A. (“Assignor”) and Eaton Corporation, an Ohio corporation, located at 1000 Eaton Boulevard, Cleveland, Ohio 44122, U.S.A. (“Assignee”) effective as of July 1, 2022 (“Effective Date”).

WHEREAS, Assignor is the sole and rightful owner of certain trademarks and/or service marks and the corresponding registrations and/or applications for registration set forth in **Exhibit A** attached hereto (collectively referred to as the “Trademarks”);

WHEREAS, Assignee desires to acquire Assignor's entire right, title, and interest in and to the Trademarks; and

WHEREAS, Assignor and Assignee are both duly authorized and capable of entering into this Assignment.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereto agree as follows:

- Assignment. Assignor hereby irrevocably sells, conveys, assigns, and transfers to Assignee, and Assignee hereby accepts, all of Assignor's right, title, and interest in and to the Trademarks, including, without limitation: (i) the ongoing and existing portion of Assignor's business associated with the Trademarks, together with the goodwill of the business connected with and symbolized by the Trademarks, (ii) all rights to and claims for damages, restitution, and injunctive and other legal and equitable relief for any past or continuing infringements, dilution, misappropriation, violation, misuse or contract breaches related to the Trademarks, with the right (but not the obligation) to sue for such legal and equitable relief and to collect, or otherwise recover, any such damages, (iii) the right to renew any registrations included in the Trademarks, and (iv) the right to apply for trademark registrations based in whole or in part upon the Trademarks, and any priority right that may arise from the Trademarks, the same to be held and enjoyed by Assignee as fully and entirely as said interest could have been held and enjoyed by Assignor had this sale, assignment, transfer and conveyance not been made.
- Recordation. Assignor authorizes the United States Patent and Trademark Office and corresponding government entities or agencies in applicable jurisdictions to record the transfer of the Trademarks to Assignee as recipient of Assignor's entire right, title and interest therein.
- Cooperation. Upon Assignee's request, and at Assignee's sole cost and expense, Assignor agrees to (a) cooperate with Assignee in the protection of the trademark rights and prosecution and protection of foreign counterparts; (b) execute, verify, acknowledge and deliver all such further papers, including registration applications and instruments of transfer; (c) take such steps and actions, and provide such cooperation and assistance to Assignee and its successors, assigns, and legal representatives, including the execution and delivery of any

affidavits, declarations, oaths, exhibits, assignments, powers of attorney, or other documents, as may be necessary to effect, evidence, or perfect the assignment of the Trademarks to Assignee, or any assignee or successor thereto; and (d) perform such other acts as Assignee lawfully may request to obtain or maintain the Trademarks and any and all applications and registrations for the Trademarks.

4. Warranty. Assignor warrants that Assignor is the legal owner of all right, title and interest in the Trademarks that they have not been previously pledged, assigned, or encumbered and that this Assignment does not infringe on the rights of any person.

5. Governing Law. This Assignment is governed by, and is to be construed in accordance with, the laws of the United States of America.

6. Entire Agreement. This Assignment constitutes the sole agreement of the parties and supersedes all oral negotiations and prior writings with respect to the subject matter hereof.

7. Severability. If any provision of this Assignment is held by any competent court, arbitrator or authority to be invalid or unenforceable in whole or in part, the remaining provisions of this Assignment shall not be affected and shall remain valid and enforceable to the fullest extent permissible under applicable law.

8. Counterparts. This Assignment may be executed in counterparts, each of which shall be deemed an original, but all of which together shall be deemed one and the same agreement. A signed copy of this Assignment delivered by facsimile, e-mail, or other means of electronic transmission shall be deemed to have the same legal effect as delivery of an original signed copy of this Assignment.

9. Successors and Assigns. This Assignment shall be binding upon and shall inure to the benefit of the parties hereto and their respective successors and assigns.



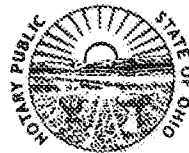
