TRADEMARK RELEASE AND REASSIGNMENT

THIS TRADEMARK RELEASE AND REASSIGNMENT (“Release”) is made as of December 8, 2022, by GOLUB CAPITAL LLC, as administrative agent (in such capacity, “Grantee”), in favor of WETZEL’S PRETZELS, LLC, a California limited liability company (“Grantor”). Capitalized terms used but not defined herein shall have the same meanings assigned to such terms in the Security Agreement (as defined below).

WITNESSETH:

WHEREAS, Grantor and Grantee are parties to that certain Trademark Security Agreement dated as of September 1, 2016 (the “Security Agreement”) pursuant to which Grantor granted a security interest to Grantee in certain Trademark Collateral (as defined therein) as security for certain obligations owing by Grantor to Grantee, including the Trademark Collateral set forth on Schedule 1 hereto;

WHEREAS, the Security Agreement was recorded by the Trademark Division of the United States Patent and Trademark Office on September 1, 2016, at Reel 5868, Frame 0497;

WHEREAS, Grantor has requested that Grantee release its security interest in the Trademark Collateral and reassign any and all rights in the same to Grantor.

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. Grantee hereby releases, relinquishes, terminates in its entirety and discharges fully its security interest in all of Grantor’s right, title and interest in, to and under the following:

(i) each U.S. Trademark registration and U.S. Trademark application owned by Grantor, including, without limitation, the U.S. Trademark registrations referred to in Schedule 1 annexed hereto; and

(ii) all proceeds and products thereof and all goodwill associated with or symbolized by any of the foregoing.

2. Grantee hereby releases its security interest in the Trademark Collateral and reassigns, grants and conveys to the Grantor, without any representation, recourse or undertaking by Grantee, any and all of Grantee’s right, title and interest in and to the Trademarks and the Trademark Collateral.
