TERMINATION AND RELEASE OF SECURITY INTEREST  
IN TRADEMARKS

This TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS (this “Release”), is made as of October 31, 2022, by Bank of America, N.A. (“Bank of America”), as collateral agent for the First Lien Secured Parties under the security agreement referenced below (in such capacity, the “Collateral Agent”), in favor of SCRI Holdings, LLC (the “Obligor”) with respect to the Collateral (as defined below).

W I T N E S S E T H :

WHEREAS, Obligor is a party to the First Lien Security Agreement dated as of November 17, 2006 in favor of the Collateral Agent (together with all amendments, modifications and supplements, if any, from time to time thereafter made thereto, the “First Lien Security Agreement”);

WHEREAS, pursuant to the First Lien Security Agreement, the Collateral Agent and Obligor entered into a Grant of Security Interest in Trademark Rights on November 18, 2016, which was recorded with the U.S. Patent and Trademark Office (the “USPTO”) on November 18, 2016, which was at Reel 5923 Frame 0881 ( the “Trademark Security Agreement”);

WHEREAS, pursuant to the Trademark Security Agreement, the Collateral Agent received a continuing security interest in, and a right of setoff against, all of Obligor’s right, title and interest in, to and under the Trademarks (as such term is defined in the First Lien Collateral Agreement), including the Trademarks listed on Schedule A hereto (collectively, the “Collateral”);

WHEREAS, the Collateral Agent desires to release any and all security interests, and any other lien or rights, it has in and to the Collateral to Obligor.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent hereby agrees as follows:

1. Bank of America hereby absolutely, unconditionally and irrevocably releases, terminates and forever discharges the security interest in the Collateral that was granted to Bank of America under the Trademark Security Agreement, and any and all other security interests, liens or other rights that Bank of America or its predecessors, successors and assigns may have in or to the Collateral under the Trademark Security Agreement.
2. Bank of America acknowledges and agrees that the Trademark Security Agreement has been terminated.

3. The parties hereto authorize and request the Director of Patents and Trademarks of the United States of America to record this Release against the Collateral. Bank of America agrees to perform all further acts and execute and deliver all further documents and/or instruments that may be reasonably necessary to carry out the provisions of this Release.
4. Bank of America hereby represents and warrants that it has full authority to execute and deliver this Release. To the extent that any other filings with any other governmental authority have been made with respect to any of the Collateral, Bank of America will execute and deliver a reasonable release or other instrument that will terminate any such filing and/or release any interests conveyed therein.
5. This Release shall be governed by and construed in accordance with the law of the State of New York.
6. This Release shall be binding upon Bank of America's representatives, successors, assigns and transferees.
