AMENDED AND RESTATED TRADEMARK SECURITY AGREEMENT

This Amended and Restated Trademark Security Agreement dated as of October 3, 2022 (this "Agreement") is made by Jazwares, LLC, First Act LLC, 1067 Studios, LLC, and Wicked Cool Toys, LLC, each a Delaware limited liability company (collectively, the "Initial Grantor"), and Zag Toys, LLC, Kelly Toys Holdings, LLC, Kelly Amusement Holdings, LLC, each a Delaware limited liability company (together with Initial Grantor, collectively, the "Grantor"), each having its principal place of business at 1067 Shotgun Road, Sunrise, Florida 33326, Attn: Judd A. Zebersky, in favor of HSBC Bank USA, National Association, as the Administrative Agent, on behalf of itself and the other Lenders under the Loan Agreement referred to below (together with any successor and assign thereto, the "Grantee") under the Security Agreement referred to below, and having its principal place of business at 452 Fifth Avenue, New York, NY 10018. Capitalized terms used but not otherwise defined herein shall have the meanings assigned thereto in the Security Agreement (as defined below).

WHEREAS, Grantor is justly indebted, liable and obligated to the Grantee pursuant to that certain Third Amended and Restated Loan Agreement dated of even date herewith (as amended, restated, supplemented or otherwise modified from time to time, the "Loan Agreement"), by and among Jazwares, LLC, Kelly Toys Holdings, LLC, Kelly Amusement Holdings, LLC, and Jazwares Soft Creations, LLC, each a Delaware limited liability company (collectively, the "Borrower"), the Grantee and the lenders from time to time party thereto, in an amount equal to the Secured Obligations; and

WHEREAS, the Grantor, certain other Credit Parties, and the Grantee entered into that certain Security Agreement, dated as of October 1, 2019, as modified by (i) a First Amendment to Security Agreement executed as of April 1, 2020 by Initial Grantors and certain other Credit Parties, in favor of Administrative Agent and the Lenders, and acknowledged by Administrative Agent, (ii) a Second Amendment to Security Agreement executed as of September 9, 2021 by Initial Grantors and certain other Credit Parties, in favor of Administrative Agent and the Lenders, and acknowledged by Administrative Agent, and (iii) a Third Amendment to Security Agreement executed as of October 3, 2022 by Grantors and certain other Credit Parties, in favor of Administrative Agent and the Lenders, and acknowledged by Administrative Agent (as amended, restated, supplemented or otherwise modified from time to time, collectively, the "Security Agreement"), pursuant to which, among other things, the Grantor has granted to the Grantee a lien on and security interest in, all of the Grantor's rights, title, and interest in, to, and under, among other things, (a) all Trademarks, including, without limitation, each issued Trademark, Trademark registration, and Trademark application listed on Exhibit A hereto, whether presently existing or hereafter created or acquired, (b) each Trademark license (specifically excluding, however, any Trademark license that by its terms would be defaulted by the granting of such security interest), including, without limitation, each Trademark license listed on Exhibit A hereto, whether presently existing or hereafter created or acquired, and (c) all products and Proceeds of the foregoing, including, without limitation, any claim by the Grantee against third parties for past, present, or future (i) infringement, dilution or breach of any Trademark, Trademark registration, Trademark application and Trademark license including, without limitation, any Trademark, Trademark registration, Trademark application, or Trademark license listed on Exhibit A hereto and (ii) injury to the goodwill associated with any Trademark, Trademark registration, or Trademark application (collectively, the "Trademark Collateral");

WHEREAS, the Grantor has duly authorized and directed the execution and delivery of this Agreement; and

WHEREAS, the parties desire to record the Grantor's grant of the security interest in the Trademark Collateral to the Grantee with the United States Trademark and Patent Office.

NOW, THEREFORE, in consideration of the foregoing and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Grantor hereby agrees with the Grantee as follows:

1. This Agreement has been executed and delivered by the Grantor for the purpose of recording the grant of security interest herein with the United States Trademark and Patent Office. The security interest granted hereby has been granted to the Grantee in connection with the Security Agreement and is expressly subject to the terms and conditions thereof. The Security Agreement shall remain in full force and effect in accordance with its terms. The rights and remedies of the Grantee with respect to the security interest granted hereunder are more fully set forth in the Security Agreement and its terms and provisions are incorporated herein in their entirety. In the event of any inconsistency between the terms of this Agreement and the terms of the Security Agreement, the terms of the Security Agreement shall govern.

2. The Grantor grants to the Grantee (on behalf of the Grantee and the other Secured Parties) a lien on and security interest in all of its right, title, and interest in and to the Trademark Collateral.

3. This Agreement may be executed in counterparts, each of which will be deemed an original but all of which together constitute one and the same original.

4. This Agreement shall be governed by, and construed in accordance with the laws of the State of New York.


5. This Agreement amends and restates that certain Trademark Security Agreement executed as of October 1, 2019 by Initial Grantor in favor of Grantee.
