## **RELEASE OF SECURITY INTEREST IN TRADEMARKS**

This RELEASE OF SECURITY INTEREST IN TRADEMARKS (this "Release") is effective as of November 22, 2022 and is given by CIBC BANK USA, with principal offices at 120 South LaSalle, Chicago, IL 60603, in its capacity as administrative agent for the benefit of the financial institutions (the "Lenders") that are parties to the Credit Agreement referenced in the Security Agreement referenced below (in such capacity, the "Administrative Agent"), to SABER POWER SERVICES, LLC, a Texas limited liability company ("Grantor").

WHEREAS, pursuant to that certain Trademark Security Agreement dated as of November 22, 2019 ("Security Agreement"), made by Grantor in favor of Administrative Agent, a security interest was granted by Grantor to Administrative Agent in the Trademark Collateral as those terms are defined in the Security Agreement, including without limitation those items listed on Schedule 1 hereto;

WHEREAS, the Security Agreement was recorded in the Trademark Division of the United States Patent & Trademark Office on November 25, 2019 , at Reel 6803, Frame 0338; and

WHEREAS, Grantor desires Administrative Agent to release, discharge, terminate and cancel its lien on and security interest in the Trademark Collateral;

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, Administrative Agent, on behalf of the Lenders, hereby terminates, releases, and discharges unto Grantor the continuing security interest in, and any other interest Lenders may have in, Grantor's right, title and interest in, the Trademark Collateral.

The Administrative Agent authorizes and requests that the Commissioner for Trademarks and any other applicable government officer record this Release.

This Release and its rights and obligations of the parties hereto shall be governed by, and construed and interpreted in accordance with the laws of the State of Illinois.

Capitalized terms used herein without definition have the meanings given to them in the Security Agreement.
