RELEASE OF SECURITY INTEREST IN TRADEMARKS

This Release of Security Interest in Trademarks (this “**Release**”) is made as of December 7, 2022, by **TEXAS CAPITAL BANK (FORMERLY KNOWN AS TEXAS CAPITAL BANK, NATIONAL ASSOCIATION)** (“**Lender**”), in favor of **FUZZY’S TACO HOLDINGS, LLC**, together with its successors and assigns (“**Grantor**”).

WHEREAS, reference is hereby made to (a) that certain Security Agreement (as supplemented or otherwise modified from time to time), November 16, 2018, executed by Grantor in favor of Lender; (b) that certain Trademark Security Agreement (as supplemented or otherwise modified from time to time), dated as of November 16, 2018, executed by Grantor in favor of Lender, and recorded in the records of the United States Patent and Trademark Office at Reel 6482, Frame 0949; and (c) that certain Trademark Security Agreement (as supplemented or otherwise modified from time to time), dated as of July 14, 2021, executed by Grantor in favor of Lender, and recorded in the records of the United States Patent and Trademark Office at Reel 7415, Frame 0592; and

WHEREAS, pursuant to the above-referenced security agreements, Grantor granted to Lender a security interest in and continuing lien on all of Grantor’s right, title and interest in, to and under those trademarks set forth on Schedule A attached hereto (collectively, the “**Trademark Collateral**”).

FOR GOOD AND VALUABLE CONSIDERATION, the receipt and adequacy of which are hereby acknowledged, Lender hereby (i) terminates and releases all security interests and continuing liens granted by Grantor in favor of Lender in the Trademark Collateral; (ii) assigns, transfers and delivers to Grantor all of Lender’s right, title and interest in and to the Trademark Collateral to the extent that any such right, title and interest exists as of the date hereof; (iii) authorizes Grantor or its designee to make filings with the United States Patent and Trademark Office and to take further actions necessary to evidence the release and termination of Lender’s security interests in and liens on the Trademark Collateral; and (iv) authorizes the governing body of the United States Patent and Trademark Office to record this Release.
