**TRADEMARK ASSIGNMENT**

FURTHER, Assignor agrees to promptly execute and provide promptly after execution such further instruments, documents or assignments as may be necessary to effectuate the purposes of this Assignment and to consolidate, vest, and record in Assignee its rights in, to, and under the TRADEMARK.

FURTHER, this Assignment may be executed by the parties hereto in any number of separate counterparts, each of which when so executed and delivered shall be deemed to be an original and all of which taken together shall constitute a single instrument. The execution of one counterpart by any Party shall have the same force and effect as if that Party had signed all other counterparts. Each counterpart may be delivered by facsimile transmission or electronic transmission, which transmission shall be deemed delivery of an originally executed document.
