RELEASE OF FIRST-LIEN PATENT AND TRADEMARK SECURITY AGREEMENT

THIS RELEASE OF FIRST-LIEN PATENT AND TRADEMARK SECURITY AGREEMENT ("Release") is made as of this 9th day of December, 2022, by LBC CREDIT PARTNERS III, L.P., as agent for itself and certain lenders and successor by assignment to Mollitiam Credit Opportunities-National Label LLC ("Assignee"), in favor of LUX GLOBAL LABEL COMPANY, LLC, a Delaware limited liability company ("Grantor").

Reference is made to that certain First-Lien Patent and Trademark Security Agreement dated as of April 14, 2017 (the "IP Security Agreement"), executed by Grantor in favor of Assignee and recorded with the United States Patent and Trademark Office on June 9, 2017 (i) at Reel/Frame 6080/0821 with respect to the trademarks; and (ii) at Reel/Frame 42744/0760 with respect to the patents, and that certain Assignment of Security Interest in Patents and Trademarks, dated as of June 15, 2018 (the "Assignment") recorded with the United States Patent and Trademark Office on June 18, 2018 (i) at Reel/Frame 6411/0459 with respect to the trademarks; and (ii) at Reel/Frame 46379/0124 with respect to the patents.

FOR GOOD AND VALUABLE CONSIDERATION, the receipt and adequacy of which are hereby acknowledged, Assignee hereby (i) terminates the IP Security Agreement and (ii) releases all liens and security interests granted by Grantor in favor of Assignee in the trademarks and patents listed on Schedules I and II attached hereto.

THIS RELEASE AND THE RIGHTS AND OBLIGATIONS OF THE PARTIES UNDER THIS RELEASE SHALL BE CONSTRUED IN ACCORDANCE WITH AND GOVERNED BY THE LAWS OF THE STATE OF NEW YORK, WITHOUT REGARD TO CONFLICTS OF LAW PRINCIPLES THAT WOULD REQUIRE THE APPLICATION OF THE LAWS OF ANOTHER JURISDICTION.


