RELEASE OF SECURITY INTEREST IN TRADEMARKS

1. Release of Security Interest. Releasor without representation, warranty or recourse, hereby (i) releases, relinquishes, terminates, cancels and discharges any lien, security interest, right, title, and interest the Releasor may have in, to, or under the Collateral, and (ii) reassigns to each Releasee, as applicable, any right, title, or interests the Releasor may have in, to, or under the Collateral, together with any and all of the goodwill of the business symbolized thereby.
