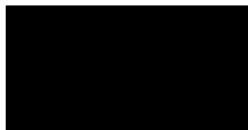

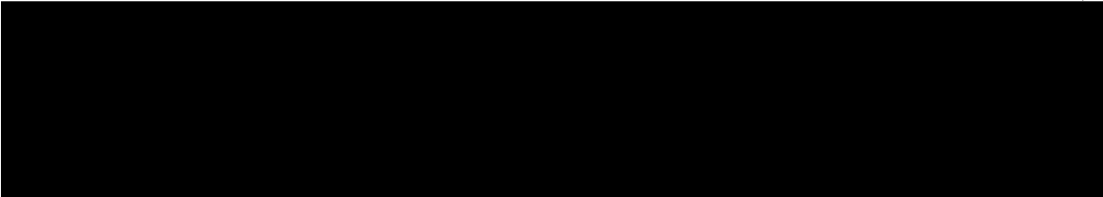


## 2. ASSIGNMENT




