**FURTHER**, Assignor agrees to execute and deliver at a future date any and all further acts, conveyances, transfers, assignments, instruments and assurances, without compensation, as Assignee reasonably determines are required to perfect Assignee’s ownership of or title to the Marks and any registrations or applications for registration therefor or to evidence the full and effective implementation and consummation of the assignment of the Marks and any registrations or applications for therefor.
